

# With Challenges, Come Opportunities

I am pleased to have the honor of serving as WSSRA president for 2020-2021. I am looking forward to the challenges and opportunities presented by the coronavirus pandemic. I have selected three priorities from the strategic plan as my focus for the year. Those three are: protecting our health benefits and pension system, increasing membership and collaborative activities, providing opportunities for social and individual growth.

Membership will be especially challenging as long as schools remain closed. Our contact with potential active members at school sites is not possible until schools fully reopen. I am hopeful that each current member can reach out to former colleagues and friends who might be potential new members. Signing up as a new member is easily done on the WSSRA website, wssra.org. We can remind potential new members that for the first time since 2011, Plan 1 members received a 3% COLA. We can also remind all potential new members that because of the current financial situation, our health care benefit is at risk. The WSSRA Legislative Committee and Legislative Director Peter Diedrick will continue to advocate for maintaining our COLA and healthcare benefits.

At our June executive board meeting, the board approved seven honorary members. To earn honorary membership status one has to have reached the age of 90, been a member of WSSRA for at least 20 years, and been an active, contributing member of WSSRA. Taken as a whole, the contributions of our newest honorary members demonstrate how our organization has continued to thrive for 73 years. Those contributions include: an 18-year member of Retirement Planning Committee, 20 years of presenting retirement workshops, preparing unit newsletters for over 20 years, participating as a convention delegate for 20 years, hosting annual unit picnics for many years, unit presidents, serving as sunshine chair for 13 years, a 25-year unit board member, a Hoban award winner, a co-chair of the Legislative committee, coordinating council chair, preparing and conducting the WSSRA "Think of Your Future" planning seminars, and an active member for 33 years at state and local level. # Virtually Adjusting to a New Normal

Where are we going from here? After a few months of dealing with COVID-19 restrictions, we're all ready for a return to the good-old-days of February. But, really, when will that happen and what will life be like in the post-coronavirus world?

For now, at WSSRA we're going virtual. With the cancellation of the 2020 Pasco Convention and the scheduling of a virtual mini-convention on June 30, the WSSRA board clearly signaled their unwillingness to hold any large gathering of members until the coronavirus is in the rear-view mirror. We all know the story about this virus: it tends to spread rapidly when people gather in groups and spend a few hours together indoors—just like what happens at a convention, or a unit meeting. And this virus is anything but kind to seniors!

So, we adjust. WSSRA has purchased a Zoom account that can be used by unit leaders to schedule virtual meetings any time. A call or email to Tara Teitzel in our office is all that it takes to get this done.

The WSSRA Executive Board has been meeting virtually since the outbreak began, and will continue to do that indefinitely. Certainly, we're hoping to get the all-clear to hold onsite meetings from the state and local health authorities before the end of 2020, but that may not happen. To be sure, we absolutely do not want one of our members to contract the virus in any manner—and certainly not at one of our meetings.

In the meantime, Legislative Director Peter Diedrick and I will use Zoom for statewide town hall meetings like occurred on June 18, one-one-one interviews like the one conducted with David Iseminger from HCA/PEBB on June 1, and legislative updates. We'll also post messages from time to time on our Facebook page, and keep the new website up-to-date.

By the way, if you haven't visited our website lately, please do so to see the new features that have been added through our partnership with AMBA and their subsidiary Vilocity.

As for the legislative outlook, we know that we'll be on the defensive during the 2021 session as Peter outlines in his update on page 4. We also have a primary election scheduled August 4 that will narrow the field in the 98 House races and 25 Senate contests that eventually will be decided in November. Members can help the WSSR-PAC and the WSSRA board by tracking races in your area and making sure that unit leaders know who will (or will not) likely be pension and retiree healthcare supporters over the next two years.

The WSSR-PAC and the WSSRA board make their endorsement decisions soon after the primary, so now is the time to do your homework on legislative candidates.

And now is the time to adjust to the new normal. We encourage all to take part in virtual unit meetings in the fall, and to help out when and where needed. Assistance with mini-grants, scholarships, community service projects, activities linked to the Health Committee Survey (see page 6), and legislative advocacy will continue in our 30 local units in 2020-21, but different pathways likely will be used to assure the same positive results are achieved. Your local leaders, perhaps now more than ever in the new, virtual world, need your involvement.

And that brings up one more "ask". If you are not getting regular emails from WSSRA, we don't have your email address. Given our upgraded reliance on electronic communication, we can't reach you for updates and presentation announcements without your email. # Fighting for our Pensions and Healthcare Benefits

### THE WSSRA POLITICAL FORECAST

The 2020 Washington State Legislative Session is officially in the rear-view mirror. Legislation WSSRA helped sponsor to provide a Plan 1 COLA, improve investment options for current employees, and lower prescription drug costs took effect on July 1. Thank you to everyone who contacted their legislators. Your advocacy made a difference. It is time to look ahead to this summer, autumn, and the 2021 Legislative Session.

### THE COVID CRUNCH

With no end in sight to the coronavirus situation, the economic and state budget outlook is grim. Economists are expecting a 4.5% decrease in United States Gross Domestic Product for 2020. Unemployment is hovering at approximately 15% nationally and in Washington State. It was hoped by all that the country's initial virus response would allow the country to return to full economic output by the autumn. That hope was ill founded, and the cycle of virus outbreaks and quarantines will continue for the foreseeable future.

The COVID-19 pandemic has left few people's lives untouched and therefore tax revenue is severely affected too. The most recent economic forecasts predict a tax revenue reduction of \$4.5 billion between now and June 2021 and another \$4.5 billion shortfall between July 2021 and June 2023. Revenue forecasting is complicated work and those more distant numbers are subject to change depending on the course of the pandemic. It is a safe bet that legislators will have their hands full.

There is rampant talk of a special legislative session prior to the regular session scheduled to start in January. Legislators considered calling a session in June to eliminate state employee salary adjustments and possibly the Plan 1 COLA. Fortunately, that plan did not come to fruition. Gossip at the capitol now indicates a possible November special session. A November session provides legislators political cover by putting off hard votes for program cuts or tax increases until after the General Election. The extra time would also allow time for the federal government to act with a state government relief package, should one materialize. Washington State has approximately \$3.5 billion in reserves and excess fund balances, so the more urgent need is to find an additional \$1.0 billion in cuts or tax revenues prior to the winter or spring.

### YOUR PRIMARY BALLOT IS IN THE MAIL

It goes without saying that this is an election year. The primary election for Washington State is August 4. The ballot will include congressional races, all statewide elected positions, the entire state House of Representatives and half the State Senate. The WSSRA legislative team has asked our organization's local and state leaders to work with legislative candidates during the campaign season and to make recommendations to our PAC and executive board on WSSRA's legislative endorsements. The PAC is meeting after the August 4 primary and needs unit and member feedback by August 1.

The nation's General Election is Tuesday, November 3. The

Democratic Party has a strong 57/41 majority in the State House and 28/21 majority in the State Senate. Democratic leadership thinks they can pick up a few more seats in the Senate due to the national political climate. Republicans are convinced that government mandated coronavirus restrictions and a new sexual education law have paved the way for Republican political gains. We will find out who is right in November.

### A RETIREE CRISIS ON THE HORIZON

The state's budget crisis will create an incentive for legislators to cut or trim retiree benefits. We believe school retirees' biggest risk lies with the Medicare Eligible Healthcare Benefit. Retirees who purchase Medicare supplemental insurance from the Public Employees Benefits Board (PEBB) receive a premium discount of 50% up to \$183 per month. That benefit has become continuously more expensive for the state and is now approximately \$350 million per two-year budget cycle. We will need your advocacy help in keeping this benefit on the books.

WSSRA will continue to improve pension and healthcare laws. Nearly all Plan 1 retirees have fallen behind in purchasing power since retirement and need continued COLA advocacy. Obtaining COLAs for Plan 1 and maintaining COLAs for Plans 2 & 3 is a permanent mission for WSSRA. Additionally, there are opportunities for pension improvements that will have little cost to the state. WSSRA will work with the Select Committee on Pension Policy to advance good pension bills as they are developed and studied by the committee. Finally, WSSRA has joined an emergency coalition with AARP Washington to protect senior services and provide adequate supplies for long-term care facilities during the pandemic.

#### IN CONCLUSION

School retirees have a fight on their hands during the upcoming special and regular legislative sessions. This is a turning point for retirees. WSSRA has been focusing on benefit enhancements and this year circumstances will force our organization to fight cuts to our pension system and healthcare benefits. The WSSRA legislative team will keep you posted as events develop, but the path forward will be difficult. As always, we will need your help. The lobbyists are only the tip of the advocacy spear. Legislators need to hear your voices to know there is power behind our words.

# Health Services Committee Survey Results

Note: What follows is a summary and analysis of the Health Services Committee survey that was sent to members in the winter and spring. Thanks to all who completed the survey, and especially to committee members Sam DeRosa and Jim Bumgarner who compiled the data and provided the analysis.

### **PURPOSE**

The purpose of this survey was to gauge the health and well-being of WSSRA by collecting member data as related to the four major elements which denote organizational health: personal and social well-being, nutrition, exercise, and financial wellness. Data collected is intended to assist the State Health Committee with decision-making regarding its health-related program and services to all members.

#### **METHOD**

At the 2019 fall meeting of the WSSRA State Health Committee, E8 Health Committee Chair Sam DeRosa submitted a draft health survey to the committee and was granted approval. Consequent approval by WSSRA's executive board pushed the survey forward with dissemination to all members.

### **Item Selection**

For each element (listed above) the survey team created questions pertinent to each. Some queries were also designed to sample members' opinions of legislative matters as to our legislative issues with the COLA and Medicare subsidy.

#### Distribution

- All members with emails received an invitation to take the survey online. An online survey platform, Constant Contact, collected, collated results, and sent them to WSSRA. All reports were, and will remain, confidential and totally anonymous.
- 2. For members without email service or computers, the survey was published in the *Journal* where they were invited take the survey, clip it from the *Journal* and mail to our state office.

3. Surveys were sent to all unit presidents who were encouraged to give their luncheon attendees, who had not yet filled one out, time to do so.

Surveys were disseminated between December 2019 and May 2020. As of May 31, 2020, we have received 1,427 surveys from members across the state.

### **RESULTS**

- Members rated their quality of life as high. The majority live with family, in their own homes, exercise on a daily basis, are active in social organizations, and volunteer in their communities.
- They are satisfied with their PEBB health insurance, but dissatisfied with the state legislature, yet express positive feelings for legislators who support our COLA/Medicare subsidy. (The survey was taken prior to recent actions by our Washington legislature.)
- Although members are meeting nutritional needs and regularly read nutrition food contents, almost half of members reported being over-weight (44%).
- A large majority of our members have a primary doctor, but half of members report a chronic health condition (46%).
- Most members do not use a walker, and have not fallen recently.
- Majority of members do not smoke or vape.
- Most have an updated will, power of attorney, and health directive.
- Monthly income comes from pension, Social Security, and investments. A few are on state assistance and military benefits.
- 75% were women.
- 60% of members live on the west side of the state.

### **SUMMARY**

The Association is populated with members who are socially involved (78%); personally active in many spheres (70%); report nutritional needs are being met (80%), still drive their own cars (95%); exercise from 20 to over 30 minutes per day (68%); financially, 92% receive a pension, 85% receive Social

### **WSSR PAC:** Is Legislative Activity **Important to You?**

This fall we are looking at an extremely important election. All our state's representatives and half of our senators will be on the ballot. As a result of the 2008 recession school retirees in 2011 took painful hits to pension checks with the loss of the Plan 1 COLA and a substantial reduction in the Medicare Eligible Healthcare Benefit. Between 2010 and 2020, Washington enjoyed a booming economy. Even with ever increasing state revenues, onetime COLAs for Plan 1 retirees were approved only twice, in 2018 for 1.5% and in 2020 for 3%. The Medicare Eligible Healthcare Benefit, for which all our retirees over age 65 are eligible, was finally restored to its 2010 level in 2019. Losing that benefit entirely could raise the premium of a Uniform Medical subscriber to \$519/month! Today, with the legislature facing the huge budget deficit caused by COVID-19, WSSRA must play a strong defense to preserve our small gains and protect against losses. We will need the help of legislators supportive of retirement issues.

The purpose of WSSR-PAC is to give financial aid to the campaigns of legislators who have supported us and those we believe will do so in the future. To help elect legislative friends, our members' contributions are vital. In past years, we have received many contributions to the PAC treasury at our convention PAC table. This year with no convention, we can't remind members in person of the importance of contributing to PAC. We urge all of you convention delegates to pull out that checkbook or cell phone now and send your contribution to our treasurer, Lora Brabant. You might send a little extra since you had no convention expenses. If your unit's low-cost fundraisers have disappeared with meeting cancellations due to COVID-19, we can't give you a chocolate bar in return for a contribution but be assured a contribution will support efforts to protect your financial future.

Our PAC executive committee meets the week after the August 4 primary to decide which candidates most deserve our financial support. We look carefully at current legislators' leadership and support for our bills in past sessions, their effectiveness as legislators, their showing in the primary election, and our members' recommendations. We also evaluate their responses to the legislative questionnaires we sent them. Most often, we contribute to legislators running for reelection because they have a solid record on which we can judge them. In some cases, we contribute to a credible challenger of a legislator who has been unsympathetic to retiree needs or to a candidate for an open seat who seems likely to help us. However, with our limited treasury we think it unwise to contribute to a candidate whose primary showing indicates very little chance of winning in the General Election. As a non-partisan group, we contribute to both Democrats and Republicans.

PAC contributions to candidates are recommended by the PAC executive committee and approved by the PAC board with representatives from all WSSRA coordinating councils. In addition, the PAC executive committee submits recommendations for endorsements to the WSSRA executive board for approval and publication in the Journal.

If you know candidates in your area whom you believe we should or should not support, please let us know. With 49 legislative districts in our state, we cannot be knowledgeable on all of them. We need this information before we make our decisions. Please send candidate information to Edith Ruby (eruby98103@yahoo.com) or Mary Wallon (mwallon21@ gmail.com) by August 1. And don't forget those checks!

Security, and over half, 51%, report income from investments. 71% report their quality of life as "high."

When asked if the legislature was meeting our Medicare subsidy and COLA needs, 21% reported being in agreement; 19% were neutral; and 58 % disagreed. (The survey was conducted while the legislature was in session.)

#### CONCLUSION

Generally speaking, since results from the survey indicate the majority of members consider themselves healthy and satisfied with their particular stations in life, it seems reasonable to assume the health of the Association reflects the same.

However, a few recommendations are offered: Specific conditions, such as weight (44%) and certain chronic conditions (46% - cardiac issues, diabetes, hypertension, etc.), could be identified for study. Presentations at meetings, newsletter articles, small group discussions designed to increase members knowledge of these conditions to assist in the development of appropriate coping skills could be made.

Summer is here and WSSRA has been through a long "dry spell" as we have adjusted to the realities caused by the coronavirus. I hope that everyone is coping well and in good health during these frustrating times. Our hats are off to our staff in Lacey as they have made many adjustments to stay at a distance and still get the work done.

Our virtual "convention" occurred on June 30 and all were impressed with how smoothly it went in spite of the learning curve involved in running it online. I know I learned a great deal.

I made the following announcements at the convention: You may recall we have had a membership incentive program for many years that awards \$100 to a local unit for adding 25 new members. We might refer to that as "Plan 1." Under that plan we congratulate Chelan/Douglas, Sno-King, and Yakima. We recently added an option that we can call "Plan 2." It involves actually handing a newly signed member a \$10 bill on the spot, as long as it occurs at a WSSRA or local unit sponsored event. 

# Unit 2 Chelan/Douglas Helps Connect Students During Closures

As with most units, Chelan/Douglas has been unable to meet due to the dangers of COVID-19. We have, however, been able to help some students in the Cascade School District (Leavenworth area) continue their education by helping them get remotely connected to their teachers and assignments. As "remote learning" was being initiated in our state, school districts were getting creative; Cascade was able to broaden their bandwidth and allow students to access district internet via hotspots in the community. Internet providers were generous in providing free Wi-Fi to families that didn't currently have it. However, in the Cascade district, it became evident that not all students could access this help even though the district could provide computers and iPads for loan. Some students lived beyond the extended networks and out of cell service range.

Because many of the student's parents still had to work, there was no one to drive them to the available "hot spots" on a regular basis or come into town to regularly pick up educational packets. Older students were often in charge of their younger siblings since parents were working.

Finally, devices and an internet connection were found that could connect these outlying areas to the AT&T network. AT&T would provide the hotspot devices, but unfortunately, the remote connection fee was very costly (\$90 a month per device!). The Chelan/Douglas School Retirees Association came to the rescue! We were able to fund the connection for 13 families (approximately 40 students) that were truly in need. Each device is able to service 5-10 computers or iPads, so families with a number of children could return to their education.

Emily Ross is the Cascade School District's Migrant/Bilingual Director as well the principal of Peshastin-Dryden Elementary school in the district. She is a CDSRA active member and was key in getting this project rolling! She provided this "thank you" from teacher Jill Weil who is working directly with some of these students. Jill is an ELL teacher and graduation specialist at Cascade High School.

"I wanted to thank you for your generous donation of hotspots for students who did not have internet access during the closures. As a support specialist for English Language Learners and migrant students, many of whom were recipients of your gift, I was able to witness firsthand the impact of your donation. I wanted to share a few of the success stories you made possible:

- 1) One of our freshman students has been caring for her younger cousins during the closures. The only person in the family with a driver's license is her older brother, who continued working full-time as an essential worker. She had no internet, no way to get to the internet access points in the county, and very little time to engage in school due to her child-care responsibilities. Nevertheless, she did all she could. She completed all the paper packets that were assigned (not many at the high school level), and tried to do online learning via her cell phone and its data plan. However, she could never download or read her teacher's Microsoft Word documents or PowerPoints on her phone, and of course could not write essays or other long responses. Once, she even tried to take a test on Zoom with her phone - it was such a challenge to control the cursor with her phone that she ended up dictating her answers to her teacher instead! She was granted a hotspot and a school laptop in May. Since then, she has done schoolwork daily in an effort to catch-up. She has committed to summer classes in order to retrieve missed credit and missed learning opportunities. In addition, she has been able to participate in non-academic (but also important) tasks like registering for next year's classes. One of the best parts of her story is that the younger cousins she cares for are also benefitting from the hotspot. They all "do school" together during their day and are moving forward academically, thanks to you!
- 2) Another 8th grader had disengaged from school completely during the closures. With no internet access and no way to access his teachers or his classes, the "incompletes" and the "missing assignments" kept piling up until his grade in every subject was a "U unsatisfactory." As soon as he received a hotspot, though, he started plowing through that pile of missing assignments. He worked hard every day and turned in multiple assignments per day. He is now receiving a Satisfactory score in all subject areas except Pre-Algebra, and -- a tribute to his work ethic -- has asked to register for an online summer Pre-Algebra course in order to stay on track and be prepared for high school. Here is a young man taking full advantage of the opportunities the technology you provided offers.

There are many stories besides these two (13 more to be precise), but these are two I've personally witnessed. Thank you for your kindness and generosity. I can tell you from my front row seat: you have had a tremendous positive impact on young people in our community."

### **Gilbert Thurston**

WSRTA President, 1991-92

Gilbert Thurston, 1991-92 WSRTA President, passed away recently. Gil lived most of his life in the Bellingham area, and was a member of the very first graduating class of Bellingham High School. After graduation he enlisted in the Marines and served in the South Pacific during World War II. After completing college at Western Washington College on the GI Bill, he taught in Camas for two years before returning to Bellingham to teach at the elementary level. He eventually became a principal and worked at six separate schools over a 26-year administrative career, retiring as the leader of Birchwood Elementary in Bellingham.

Upon retiring, Gil joined the Washington State Retired Teachers' Association, serving in a number of leadership capacities including president in 1991-92. As president, Gil focused on building partnerships with WEA, AARP and PERS, closely monitoring the state investment board to assure that pension funds were properly managed, and continuing the quest for a permanent Plan 1 COLA. He strongly believed that WSRTA members should be involved in their local schools, and work diligently to promote public education.

In addition to his work with WSRTA, Gil was a charter member and president of the Association of Washington School Principals, and was a board member of the National Association of Elementary Principals and National PTA. He also was an AARP-WA Health Coordinator, chair of the Whatcom County Red Cross, chair of the Whatcom County Alliance for Healthcare Access, and chair of the Washington DSHS Mental Health Advisory Council—four of the many community service organizations that he served. He was preceded in death by Inge, his loving wife of 71 years. He is survived by four sons, six grandchildren and five great-grandchildren.

# Scams, Scams, and More Scams

With the recent press coverage of the millions of taxpayer dollars lost in coronavirus-connected scams that issued phony unemployment checks to cyber-crooks, fraud is in the news—yet again.

At the WSSRA office, we get calls and emails just about every week about a new scam that is "out there." For instance, lately criminals have found a way to use names of friends or acquaintances who have, according to the story, a "grandson who needs surgery," or a "daughter who just found out she has cancer" as a way to pull on the heart strings and send a couple of gift cards to make everyone feel better.

Warning: Gift card "asks" scream scam! Gift cards are easy to sell on the dark web and are pretty much untraceable. In the last two years, scammers have even used the names of WSSRA leaders (for example, Presidents Curt Horne and Pam Francis) as the ones asking for money. Not true. When you see one of these emails from a "friend," delete it and then let the person know that their name is being used by scammers.

As a rule of thumb when reading shaky emails or listening to crazy phone messages, remember that offers that appear to be too good to be true, probably are. In addition, an email asking you to help a "friend" undoubtedly didn't come from one. The take-away on all of this is: DELETE, DELETE!



### **NORTHWEST-1**

Unit 1 Clarkston/Asotin/Pomeroy member and E8 District Representative, Sharon Hoseley has been hard at work. Here is her story...

Beginning on March 19, my granddaughter, Haelee, and I began sewing cloth face masks. We want people to be safe and know that many cannot afford to buy masks.

We began with a stash of material I had on hand. We sew each Tuesday, Wednesday, and Thursday. Haelee sews the first round and turns them insideout. I pleat and do the finishing two rounds. We make three sizes: small, medium, and large because one size does not fit all and people won't wear them unless they fit. Every time the stack of cloth gets low, a sack with more shows up on my doorstep, plus thread and even paper lunch sacks to put them in. I've received some donations of money, which I use to purchase elastic.

The masks are free. Each order goes in a sack with the person's name on it and is placed on my front porch for the people to pick-up. In each bag, I put this note: "With each mask I've sewn, I've prayed for the one who will wear it. We all want this to end. God promised: "I am God. At the right time, I will make it happen." Isaiah 60:22"

Cards and notes of thanks are overwhelming. We average about 80 masks each week. As of mid-July, we've made over 1,760 cloth masks.
