### **WSSRA Retirees Using PEBB for Medicare Supplemental Insurance--**

**On July 14 the PEB Board approved 2023 Medicare Supplementary rates as follows:**

**With significant cost differences between UMP Classic (the preferred choice by the majority of retirees) and the other options, Ellen Wolfhagen and David Iseminger from the Health Care Authority (HCA) will present the latest on this situation in a webinar on Monday, August 22 at 9:00 a.m.**

**Ellen is a Senior Account Manager for HCA and David is the Director of the SEBB and PEBB programs. Both have been heavily involved with the recent cost challenges with UMP Classic and the advent of the UHC Advantage plans, one of which (UHC-Complete) that was bid out to be the equivalent of UMP Classic. They will brief the audience on eligibility, costs, coverages and claims of the UMP alternatives with a special emphasis on experiences with UHC-Complete in 2021 and 2022. Information about Kaiser Permanente and Premera also will be provided.**

**Switching plans must take place by November 30. With cost differences now significant, those contemplating making a Medicare supplement change for 2022 will be interested in the information provided.**

**Ellen and David will present through a series of slides and then take questions from attendees. The webinar will be recorded and posted on the WSSRA website.**
